## Biography

Arjun Garg, formerly the Chief Counsel and Acting Deputy Administrator of the Federal Aviation Administration (FAA) and also the Chief Counsel of the Federal Transit Administration, is an authority on transportation law and advises clients across a variety of aerospace and other transportation issues.

Arjun is an established leader in the aviation industry whose clients benefit from his versatility. With experience as a regulator, litigator, and counselor, Arjun combines technical skill as a lawyer with the strategic perspective of an executive and the relationships of a senior government official.
